## Required Signs

You are required to post a number of signs and licenses at your business based on your license type.

WSLCB enforcement officers and local law enforcement will look for these signs and licenses when visiting your business to ensure you are complying with liquor, tobacco and cannabis laws.

## Liquor Signage

### **Note for Spirits, Beer and Wine Restaurants on posting signage:**

Spirits, beer and wine restaurant licensees must post their own sign, which states that food service is available whenever liquor is sold and what the hours of full food service are, in the lounge. WAC 314.02.035



### To-Go Alcohol Safety Requirements



To-go alcohol customers must  
follow these state requirements  
and prohibitions.



To-go alcohol must be kept out  
of the driver's reach.



Opening or consuming alcohol  
in a motor vehicle is prohibited.\*



Public consumption of alcohol  
is prohibited.\*\*

\* RCW 46.61.519 - restrictions on drinking or having an open container in a vehicle.

\*\* RCW 66.44.100 - restrictions on consuming alcohol in public place.

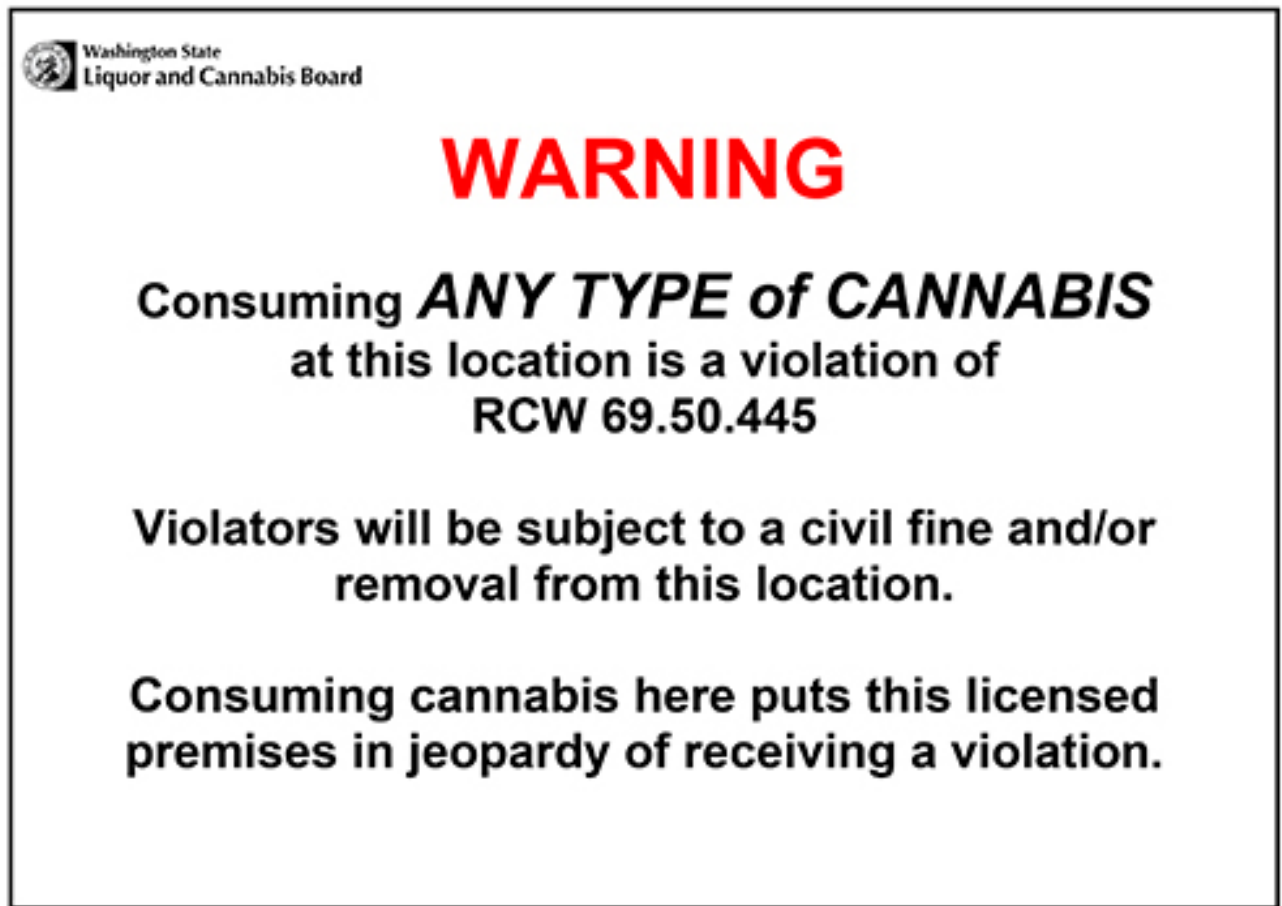
